- **(4) Resolution 2025-05: Seasonal Employees Bonus Pay:** Resolution 2024-12 passed last year to help with employee recruiting and retention to increase the bonus per hour worked to \$0.50. This resolution helps to define other criteria regarding starting pay, bonuses for seasonal staff, as well as the time period for the bonus pay. A motion to approve Resolution 2025-05 was made by Mr. Lawrence, seconded by Mr. Fails and passed unanimously with a vote of 2-Yes, 0-No.
- (5) Resolution 2025-06: Amendment to the Agreement with Thomas Porter Architects for Design, Permitting, Bidding, Construction Admin for Fremont Rotary Lodge Renovations Entering into a Contract with Thomas Porter Architects for Construction Administration: Thomas Porter Architects previously submitted a proposal to provide construction administration and design services for the Fremont Rotary Lodge at Don W. Miller Memorial Park renovations approved by this board. (Resolution 2023-23)

The attached amended fee proposal reflects the modifications made throughout the project. These adjustments accommodate the transition from a single design phase under a single prime general contractor to a CMR procurement (Telamon) with a three-phase drawing package, where GMPs 1 and 2 have been completed.

Additionally, the proposal includes a \$50,000 line item for the GMP 3 permit/construction drawing package, which remains to be finalized. This amount is expected to be sufficient to complete the full design of the pavilion, contingent on the ability to secure funding for that portion of the project. The total fee proposed based on the above listed services for this project is a Not-To-Exceed fee of \$275,000 which includes the previous Not-To-Exceed fee of \$125,000. A motion to approve Resolution 2025-06 was made by Mr. Lawrence, seconded by Mr. Fails and passed unanimously with a vote of 2-Yes, 0-No.
